

First Capital Equity Fund

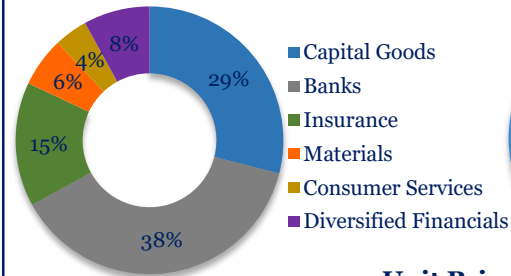
Fact sheet as at 31 December 2020

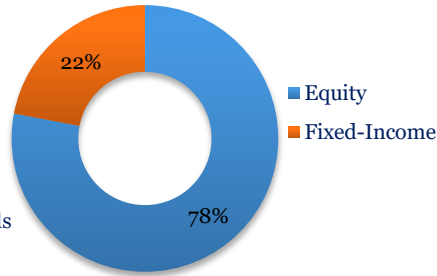

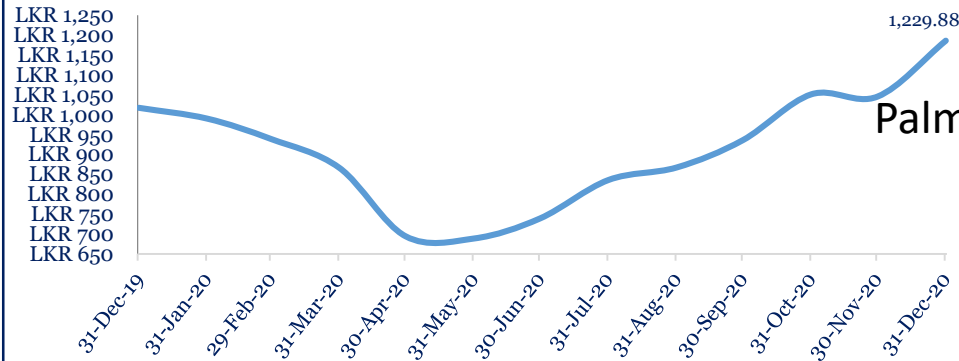
Industry Group Exposure



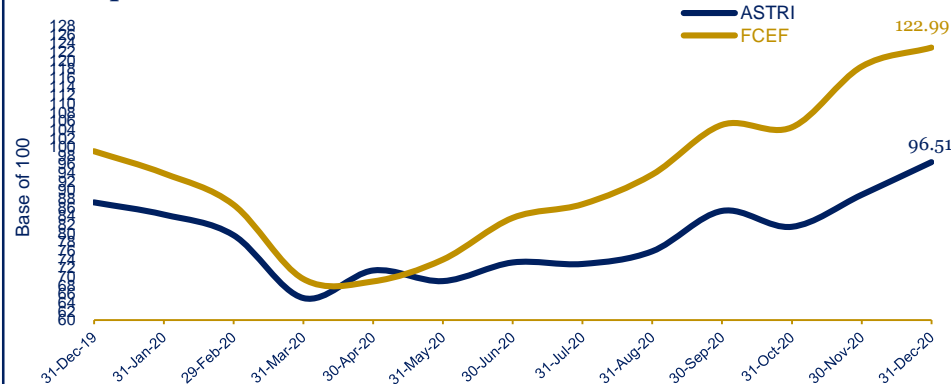
Asset Allocation
