

# First Capital Equity Fund

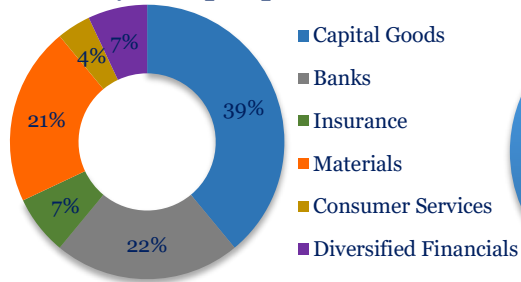
Fact sheet as at 31 August 2020

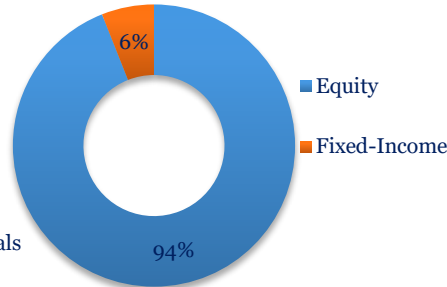

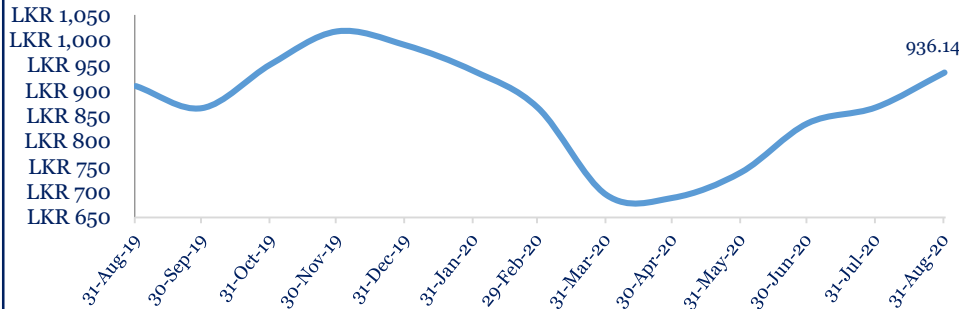
## Industry Group Exposure



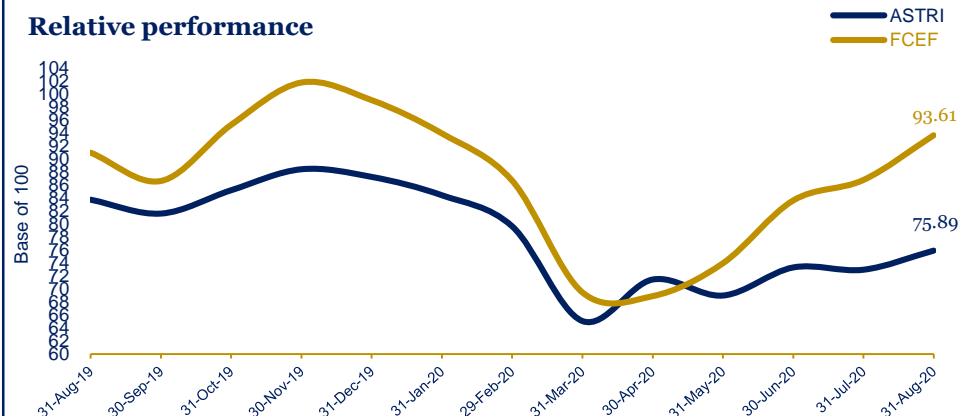
